#### **BOOKINGS OPEN!**

Following on from a successful event last year, this year's funding festival will look at raising money for work at the heart of your community.

It will be particularly relevant for community spaces at village halls.

#### Topics will include:

- How to use your community space to bring economic benefit to the local community
- Raising money together community fundraising, crowdfunding and how to do it reliably over time
- Big one-off building projects how to make it happen
- Going green getting money for green initiatives and improvements

Plus, how to make your bids stand out, meet the funders and a chance to network and swap ideas. We will also be giving away fact sheets and other useful material to help you to tackle the challenges for your organisation.

Do note that this event will cost £5 per booking (no matter how many people are coming from your organisation) of which £2 will go into the "pot" which can be won by making a strong "pitch". (See below on how to make a good pitch for funding.)

Every organisation coming on the day can bring a one-side of A4 pitch for how they would spend, say, £100.

Participants will vote for the best one and that one will get the whole pot.

**Information:** Patient Safety Partners will help NHS Dorset to ensure the NHS in Dorset can become the best place for patient care.

Do you work with young people aged 16-17 or 16-24 with SEND, care leavers and those experiencing mental health difficulties?

We have been working with groups of young people to come up with a solution to an issue that is affecting them or their community.

Events have included raising funds for a common room, a children's charity and an animal rescue. We have enjoyed a wii bowling tournament, a film event, a cupcake sale, making jam and created a courtyard kitchen garden among many others.

The projects covered topics such as planning, budgeting and promotion and are designed to support a participant's personal development by improving their confidence, communication and team working skills.

Building their employability skills, connections and opportunities within their own community.

Participants have told us that their confidence has improved, they have enjoyed learning how to run a successful event and how to work well in a team.

#### **ADVICE SESSIONS for FRONTLINE WORKERS & VOLUNTEERS in 24/25**

Are you a volunteer or frontline worker supporting under-represented communities who may struggle to pay their energy bills this winter?

We are pleased to announce Dorset Community Action has been successful in securing funding to deliver Energy Insecurity Awareness Training for frontline workers, staff and volunteers for the remainder of 2024 and 2025, in partnership with the Big Energy Saving Network and Citizens Advice Bureau.

There have been many changes since March 2024 with a new government, changes in policy, changes in energy price caps and in financial support available for individuals. For those who have not accessed the Energy Outreach Advice Training previously, this is an opportunity to learn the latest on how you can support your under-represented communities to provide valuable information on how to save on energy bills this winter, be more energy efficient, signpost to energy schemes, upgrade heating or replacing appliances and make referrals to access grants and fuel vouchers.

For those who attended previously this is an opportunity to Refresh and Upskill yourselves or to book for new members of your team.

The training will be for one hour and we will cover topics such as:


- Energy Efficiency

Energy Outreach Project, formerly known as Big Energy Saving Network, is an outreach only energy advice programme delivered across England and Wales.

It is delivered by a network of Champions and Regional Energy Leads, based in local organisations. Are you a Frontline (Key) Worker, working with hard to reach and/or under-represented communities? Do you know enough to spot the signs of fuel poverty or to advice your clients on where to go for advice and support?

If not, we can help. DCA in partnership with NEA and CAB can provide free training to frontline workers to support their vulnerable clients/patients. This training is delivered by a qualified member of staff from Dorset Community Action. It can be delivered to your team in person, or on-line. The training will be for one hour and will include handouts of further information from the session.

#### Annual report season is upon us:

For most charities with a financial year around end of the end of March, the summer is a period of finalising the year's accounts and pulling together the Trustees Annual Report ahead of the Annual General Meeting in September or October.

Most charities have to do a formal report to go with their accounts, and may also be pulling together reports for funders. However, it is also useful to consider creating a brief impact report as well. The other reports look at what you did - and what it cost - but what interests your supporters is the difference your work makes. You know the stories, the comments people have made, the stats for what you have accomplished, but they don't often make it into the reports. How about creating a brief report, something visual, showing-rather-than-telling people the highlights of the difference you made last year? Your community, volunteers, prospective volunteers, service users - and even funders - will be shown a whole different perspective.

You also have to submit your annual return to the Charity Commission (between this month and the end of January next year for people with a March year-end). This means you have to do different things depending on the size of your turnover:

- Under £10,000 and unincorporated charity or charitable company a simple income and expenditure report
- If you are a CIO (or unincorporated charity or charitable company with a turnover of £10,000 to £25,000) you need to answer a number of questions, including your income and expenditure, where your income came from, where it went and what policies you have in place. You can see the 2023 questions <a href="https://example.com/here">here</a>. The 2024 questions will be available later this month, keep an eye on the Charity Commission's site.
- Over £25,000 You must answer the questions about your charity plus declare that there are no
  serious incidents that you have not reported to us. (Report serious incidents before you submit your
  annual return.) You will need to get your accounts checked and provide copies of your trustee annual
  report, accounts and independent examiner's report. These links relate to the Charity Commission's
  guidance.
- Over £1m you are required to do all the above, plus submitting fully audited accounts. (You may have
  a full audit on your accounts under this turnover for various reasons.)

Incidentally, the person doing the reporting needs to have set up their <u>My Charity</u> <u>Commission Account</u>, using an individual email address and password, to access services on behalf of a charity. This system changed this time last year.

#### Making an effective pitch:

As part of the funding festival, we are inviting everyone who comes on the day to pitch for a pot of money. Whoever is voted the winner, gets the whole amount raised. It can be hard to know what to say to attract funding; how exactly to sell yourselves, so here are four practical suggestions:

- Talk about the difference you make, not what you do; i.e. we help lonely older people to get out and make friends, not we run lunch clubs. Tell your story in a way that we can relate to -maybe use your service-users' own voices to show what you do.
- Talk about what makes you unique as an organisation, as a project or as an idea. Why is your idea the one we need to support rather than the community centre down the road?
- Be specific; what will you do with this money and how will this money help you to make a difference?
- A picture tells the best stories; happy children, laughing older people, snoozy rescued kittens well worth making space for.

It is always worth getting your pitch critiqued by others - both those who know about what you do and then try practicing the pitch to a friend who doesn't. Is it clear, does it tug at the heart strings - and the purse strings...?

#### Is your group or charity having the right meetings?

If you are a trustee of a charity or constituted group, it is worth checking that you are abiding by the rules set out in your governing document. If yours are very old, then they may not be as up-to-date as needed. Your governing document is clear about the ways you can hold meetings. If you want to hold <u>virtual or hybrid meetings</u>, it should be amended to specifically allows you to do so. The Charity Commission's guidance, <u>Charities & Meetings</u>, says:

"You should amend your governing document if:

- it does not say anything about meetings
- it does not give enough details about meetings, for example rules about how to vote at meetings
- it has rules that are no longer workable

"This may help your charity to work effectively in the future. You do not usually need the Charity Commission's authority to make these changes."

DCA can help you to with this; from going through the constitution and helping draft new wording, meeting with trustees to even talking to the Charity Commission on your behalf. Funder: Physical Activities Grant - Parkinson's UK

**Who can apply:** UK based organisations with a business or commmunity bank account.

**How much?** Up to £3,000.

**Focusing on:** Innovative and new projects that help people with Parkinson's become active and stay active. For those who are already active to increase their levels of activity.

Important dates: Will stay open until all funds are allocated.

Funder: Wessex Water Community Fund

Who can apply: Registered Charities, Constituted Community and Voluntary organisations, CIC's limited by guarantee, Companies liminted by guarantee that have a clear not-for-profit clause and clear chartiable or social objectives, Parish Councils may apply if they can demonstrate clear social objectives.

How much? Grants of up to £4,000.

**Focusing on:** Aims to support local groups and activites that benefit local people in areas of multiple deprivation or areas of rural isolation; helping to build stronger communities, helping people to take steps to manage debts, bills and building financial capability.

**Notes:** Will fund core and running costs as well as project and activity costs.

Important dates: This fund closes on 18th October 2024.
