#### Tune into The Village Halls Podcast -

A podcast for Britain's 10,000 village, church and community halls and anyone interested in the vital community services they provide. The second phase of NHS England's Pharmacy First Campaign has launched and assets are now available on the <u>Campaign Resource</u> <u>Centre</u>. The campaign aims to increase the public's awareness of the breadth of support community pharmacists can offer to patients on their doorstep. It focuses on the Pharmacy First service that allows pharmacists to provide some prescription medicine for seven common conditions, if needed, without the need to see a GP or prescription

#### Wednesday 27 November was National Energy Action's Fuel Poverty Awareness Day (FPAD). Six

million households are in fuel poverty, with a growing mountain of debt putting pressure on those least able to afford it. The energy crisis has been going on for over three years, meaning household budgets have been stretched and many are struggling in cold, unsafe and unhealthy homes. Debt is at record levels with households over £3.7 billion to their supplier. The situation is stark with people either having to accrue debt or live in homes that will negatively impact their physical and mental health. You can download their media pack here.

In January 2025, we will be opening up the scheme to a total of 5 community spaces. The ACRE Hallmark is a standard that helps community spaces to look at their systems and how they do things from major policies to meetings to giving keys to hirers. Achieving a Hallmark can reduce your costs and gives everyone confidence that you are a well run community space. DCA is the certified ACRE assessor for Dorset.

Hallmark assessments will be FREE until 31st March 2025. After this, there will be a charge for the assessment process of £135 + VAT for Hallmark 1 or 2 or £200 + VAT for both together and £100 + VAT for Hallmark 3. #### ADVICE SESSIONS for FRONTLINE WORKERS & VOLUNTEERS in 24/25

Are you a volunteer or frontline worker supporting under-represented communities who may struggle to pay their energy bills this winter?

We are pleased to announce Dorset Community Action has been successful in securing funding to deliver Energy Insecurity Awareness Training for frontline workers, staff and volunteers for the remainder of 2024 and 2025, in partnership with the Big Energy Saving Network and Citizens Advice Bureau.

There have been many changes since March 2024 with a new government, changes in policy, changes in energy price caps and in financial support available for individuals. For those who have not accessed the Energy Outreach Advice Training previously, this is an opportunity to learn the latest on how you can support your under-represented communities to provide valuable information on how to save on energy bills this winter, be more energy efficient, signpost to energy schemes, upgrade heating or replacing appliances and make referrals to access grants and fuel vouchers.

For those who attended previously this is an opportunity to Refresh and Upskill yourselves or to book for new members of your team.

The training will be for one hour and we will cover topics such as:

- Energy Efficiency
- COL & Fuel Poverty
- Fuel Poverty and Health Impacts
- Debt Advice & Grants
- Your Rights as a Consumer

**Focusing on:** Organisations working with disadvantaged children and young people aged 18 and under.

#### Funder: <u>Neat Streets Grant Round 2</u>
